#### **'HUGE NEWS'**

NLRB seeking injunction that could end Pittsburgh news workers strike

The National Labor Relations Board authorized the regional NLRB office to seek an injunction in the guild's and sister unions' case against the Post-Gazette for dozens of ongoing unfair labor practice violations of federal law.

Possibly at stake, Zack Tanner [president of the Newspaper Guild of Pittsburgh] said, "We're talking millions of dollars" that a federal judge could compel the company to pay, including to "make whole" workers for at least some of their losses, while also ending the strike and sending the strikers back to work and back to the bargaining table.

## JOURNALISM COLLABS WITH LEGISLATURES TO SAVE LOCAL NEWS

California: SB 1327 proposes Big Tech tax to help fund news jobs (from TNG newsletter)

Senate Bill 1327, sponsored by California Sen. Steve Glazer, would implement a Data Extraction Mitigation Fee on massive tech platforms that have displaced tens of thousands of local journalism jobs across the U.S. The platform fee would generate revenues for a refundable employee hiring and retention tax credit that's designed to preserve and create journalism jobs in local newsrooms across California.

New York: News Guild-CWA Achieves Historic Legislative Win (from CWA Newsletter)

The New York Assembly and Senate [in late April] passed a first-of-its-kind journalism jobs tax credit in the 2025 budget. The credits will become law when New York Governor Kathy Hochul signs the state budget.

The job tax credits were first introduced as the Local Journalism Sustainability Act (S.625-Hoylman-Sigal/A.2958-Woerner). The final budget language provides \$30 million in tax credits each year over three years, covering half of a journalist's salary up to \$50,000 each year. Publishers will only be able to use these employment tax credits to rebuild their newsrooms by hiring new reporters and retaining current staff.

The organizing effort for this initiative has been spearheaded by the Albany Newspaper Guild, New York News Publishers Association, the New York State AFL-CIO, NewsGuild-CWA, and the Communications Workers of America.

NewsGuild-CWA President Jon Schleuss said, "Journalists are the watchdogs of democracy's flame and we have to support them. The NewsGuild-CWA applauds New York state for leading the country and passing first-of-its-kind legislation to support journalism jobs and recognizing the important role journalists play by shining a light and protecting our democracy."

A sold-out house watched the documentary "Stripped for Parts: American Journalism on the Brink" last month at the local MSP International Film Festival.





The April 10th journalism forum in Duluth addressed more than its promoted agenda of 'covering politics in greater Minnesota.'

Questions were posed to the panel about the role of journalists in a divisive political climate, how they can do a better job covering races and issues in communities outside major metropolitan areas, and how they can work together to combat misleading news. Answers focused on understanding regional issues of importance, getting local perspectives, fact-checking, and selecting appropriate delivery formats.

The forum drew a standing-room only crowd of more than 100 people to the Zeitgeist Performance Theater in downtown Duluth. It was a successful beginning to what many in attendance hope will be more jointly sponsored journalism events across the upper Midwest.

## UNIT UPDATES

Make Good Trouble: Labor Notes 2024 Report

The MN Guild sponsored (for \$500 each) two members to attend Labor Notes this year. Below is a brief account from Larry Nelson (FairVote MN).

Last month I had the opportunity to return to Labor Notes, the large labor conference that takes place in Chicago every two years. This year over 4,500 union members and supporters attended from around the world, including over 140 News-Guild members.

Many NewsGuild members also lead workshops. I attended several that talked about the need to create member engagement or find ways to include new members. Strategies included building a culture of unity through, for example, holding monthly meetings where all members are included. Also, having a good network of stewards that will listen to members and bring concerns to both management and union leadership. Another takeaway was how important it is to keep organizing even after you have won your union so you can go into contract bargaining in a strong position. We also create member engagement through doing one-on-ones with members, explaining not only that they are part of a union but why it's important that the union exists and the need for members to be involved.

The conference concluded with a panel that included UAW president Shawn Fain who was fresh off a huge union victory in Tennessee. He compared the work UAW members did fighting fascism in WW2 building liberator bombers to the work being done today to create a fairer, just economy; 'The working class is the arsenal of democracy, and workers are the liberators."

The next Labor Notes Conference will be in 2026. I hope to see you all there.


